Entry Deadline:

Limit of 6 teams.

- If events have not been filled by May 15, 2025, contestants may enter a second team.
- A release of liability signed by the contestant or contestant & parent/guardian is required for all events.

The entered contestants will be allowed free admission to the Fair on **Saturday, May 17, 2025.** All other individuals in the vehicle will need admission passes.

Contestant names will be on a list at the lower gate.

Age Restrictions:

Age is determined by the contestant's age on January 1, 2025. To compete in the Stampede Events, a contestant must be at least 9 years old as of January 1, 2025.

What to wear:

- All contestants, particularly junior contestants, are encouraged to wear a helmet during competition.
- All contestants must wear a cowboy hat or helmet and long-sleeved western style shirt or blouse.

Entry Fee: \$50

The winning team of 3 will win a Trophy Buckle.

Hide Race

Three-person team, one mounted rider and two hide riders. Hide riders must wear safety helmets and safety glasses/goggles. Gloves, coveralls are suggested but optional for all riders. Mounted rider starts behind designated chalk line with hide dallied to horn. Hide rider #1 will be in prone position on the hide. Time will begin once the horse's nose crosses the start/finish line. Team will race to the other end of the arena across the designated chalk line and must stay outside of the barrel. Hide rider #1 will dismount the hide and hide rider #2 will then get in prone position on the hide. Hide rider #2 must be in position before crossing the designated chalk like to race back to the start/finish line.
