Amelia mentioned that we would lose about 95% of small animal kids so would have to do market pictures. He has 3 sponsors to cover the full \$3,000.00 and in return would have their name on each photo. Laurie said she would have to get approval to have sponsors on the photos. John also said he has a photographer that would do it. He will bring them to the November meeting. There were lots of discussions after Kathy left so this item was tabled with options until November.

<u>Goat panels update - All are here or at Bret Harte, not all are done.</u> Did use some that were completed by Nick Musachia. There was a suggestion that we use the extra sheep fronts.

He goes through Heather the banner design girl. She designs buckles then farms out for production. Laurie said the fair has used "A Cut Above" and liked them. Sheryl will do some research.

<u>Contract for Jim's / Klaussen's for swine processing</u> - They are one in the same now as Klaussen's bought Jims Farm.

<u>Elections for JLC Board.</u> - Ballets available. Sheryl motioned to keep board the same as long as they agree. John 2nd motion. All board members agreed, and the motion passed.

Bylaws - Art has these and is absent so tabled until November

<u>Premium book corrections</u> - The corrections have been approved, the book is ready for print.

Auction payments - Laurie reported we have one left for \$2400.00.

Items to place on the next agenda - Bylaws, Fan, Rule change results, Photographer.

May stay as an every year requirement. **There is a big push to change state rules, nothing allowed except food and water for animals. This means no supplements etc.
